Jessica Milosky is qualified to provide professional clinical counseling services. Jessica works with individuals and families to treat, improve, and/or resolve symptoms related to mood disorders, ADHD, autism, relationship conflict, life transitions, grief, and trauma. She sees clients ages 12 and up at the Surfside office and Conway office and provides Trauma-Informed Equine Assisted Therapy services to clients ages 5 and up at The Barnabas Horse Foundation in Murrells Inlet. Jessica also offers telehealth counseling services.

**Fee Schedule:** \$150/ per Clinical Hour/\$190 per Intake Assessment. Sliding Fee Scale (\$120-\$190). There is a \$25 fee per 15 minutes of services provided outside of regularly scheduled sessions, unless those services are billable to insurance. Fees are applicable to administrative requests.

**Artificial Intelligence (AI):** The clinician utilizes Blueprint AI for documentation purposes. Blueprint's note-taker temporarily records sessions and uses this recording to automatically generate a progress note (a required form of clinical documentation). After a progress note is generated, the recording is automatically deleted from Blueprint's servers and database, and the transcript will be manually deleted by the clinician and deleted from Blueprint's servers and database.

**Cell Phone Policy:** The clinician may provide her personal cell phone number for emergencies, ONLY. By signing this document, the client understands that the clinician's personal cell phone is not a HIPPA-compliant device, and the client waives his/her rights to confidentiality if the client contacts the clinician on this platform.

**Cancellation Policy:** Please note that a \$100.00 fee will be charged for each occurrence if appointments are not cancelled with at least 24 hours' notice. If a late cancellation can be rescheduled within the same week, the fee will be waived. The opportunity to reschedule is not guaranteed and may only be available as a virtual session.

**Barnabas Horse Foundation:** BHF is a non-profit organization that offers trauma-informed equine assisted therapy services to victims of trauma (individuals traumatized as a direct result of the actions of another person). A weekly commitment is required, and effectiveness and appropriateness of services is evaluated quarterly. Barnabas does not charge for their services and is grant funded by the state of South Carolina, however, a \$50 fee is charged by Barnabas for late cancellations (less than 24 hours' notice) and payment is required before or at the start of the next session. Also, regardless of circumstances, if 3 or more sessions are cancelled by the client within any one quarter (3-month period), the client may be asked to leave the program and reapply at a future time.

\*\*\*Please note that BHF fees are separate and in addition to late cancellation fees charged by the clinician.
